



**Mission Hills North
2025 CV Discount Card**

A CV (Coachella Valley) Discount Card holder must reside in one the following cities: Palm Springs, Desert Hot Springs, Thousand Palms, Cathedral City, Rancho Mirage, Palm Desert, Indian Wells, La Quinta, Bermuda Dunes, Indio, Coachella, Thermal, and/or Mecca.

To verify your residency, you must present the following two hard copy items, and both must be present at time of purchase:

1. A current and original (*within 90 days*) utility bill (*cable, electric, gas, or water*) with the same name and address as the CDL, or Property Tax Bill (*see cities listed above*).

PLUS

2. A current (2024/2025) Riverside County Tax Assessor Record (*Property Tax Bill*) in your name and address (*see cities listed above*) along with valid photo ID with same name.

OR

A current California Driver's License (*CDL*) issued by the Department of Motor Vehicles (*DMV*) with your physical Coachella Valley address on it (*see cities listed above*). **NO ID CARDS**

*** A person may use his/her spouses' utility bill, but it must reflect the same last name. If the last name is different, a marriage certificate is required. ***

**Cards shall be issued on Monday, Wednesday, and Friday
from 9:00am – 1:00pm ONLY.**

1. CV Discount Card must only be used by the registered card holder.
2. CV Discount Card holders may book tee times starting at 12:01am, 5 days prior to date of play.
3. CV Discount Card holders reserving a tee time or playing as part of a group/event that was booked outside of the above booking window, will be charged the full posted rate for that day.
4. Any CV Discount Card holder that is caught booking outside the window, canceling their time within the window, then rebooking for the CV Discount holder rate will have their card and privileges revoked – ONE STRIKE POLICY.
5. You must have your card present each and every time you check in. **No card, no discount, no exceptions.** You will be charged full rate if card is not presented.
6. Guests (*up to three (3)*) accompanied by a CV Discount Card holder will receive the CV Discount Card Guest Rate (*see current rates for more details*).
7. CV Discount Card holders are required to guarantee tee times with a valid credit card. No-Show / Short Shows will be billed the full posted rate. Cancellations are accepted but must be received at least 48-hours prior to the scheduled tee time.
8. All CV Discount Cards expire on December 31 each year.
9. Lost or stolen cards may be replaced for a fee of \$50.

Notice

There is NO EXECPTION for inability to provide proof of residency. Mission Hills North reserves the right to refuse CV Discount Cards to anyone and make changes to the program at any time, without notice. The following is a list of items that do not qualify as documentation for a CV Discount Card;

- **No Time Share Agreements**
- **No Bank Statements, Deeds, HUDs, or Leases**
- **No other Golf Course or City Resident Cards**
- **No use of Mission Hills North facilities to garner the needed information (internet, fax, etc.)**

ALL CV DISCOUNT CARD HOLDERS ARE RESPONSIBLE FOR THEIR ACTIONS AND THOSE OF THEIR GUESTS IN ACCORDANCE WITH THE CODE OF CONDUCT AGREEMENT ON THE 2ND PAGE OF THIS FORM.
